Promotion: Corks & Kegs Wine & Beer Festival will use numerous media to promote the festival including: posters widely distributed throughout the area, newspaper, radio, tourism associations, and social media.

Vendor Eligibility: Any licensed business with an approved product is encouraged to apply. Vendors are admitted in the following categories at the discretion of the Event Organizer, who reserves the right to refuse entry to anyone, based on issues of balance of like-products, timeliness and thoroughness of application, and appropriateness of product to the client event.

- Agricultural products must be commercially prepared, packaged, and labeled. Proof of liability insurance must be provided with application. Foods may be sampled on site, but are sold for at-home consumption.
- Arts/Crafts handcrafted items that must be original, unique and represented by the artist at the festival. All media are eligible and encouraged.
- Food vendors. Food vendors are those selling food for consumption on site. You must submit a typed menu of no more than five items. Duplication of items is limited so you may be asked to remove an item from your menu. Mobile vending units and food trailers **MUST** submit exact dimensions (including tongue) with the application. **Electric requirements, health permit, and proof of liability insurance MUST be submitted, even if you have been a vendor previously.**

Location: Soccer Fields at Burn Lake Park- Burn Lake Rd Las Cruces, NM

Security. Security will be provided from 5:00 PM on Thursday through 9:00 AM on Monday. Southwest Wines nor Las Cruces Event Planning will be responsible for damages, theft, or loss before, during or after festival hours.

Exhibition Space. Booth space is 10'x10'. Exhibitors must provide booth structure, tables, and chairs. You are encouraged to provide sun, wind and rain protection for your booth space. Vendors who do not secure their booth properly for the weather will be liable for damages to other structures and/or injury to other individuals. You may rent a professional 10x10 tent with 4 walls from the event for \$195. The tent will be set up and ready for your arrival on Thursday. Vendor spaces are assigned based on date when complete applications are received and written requests for special placement. Special consideration is given to placement that affects product quality, but request must be in writing on the application. Vendor site placement is FINAL and will not be changed by the festival management

Show Hours: The show hours are **5pm to 10pm on Friday and 3pm to 9pm on Saturday & Sunday**. Vendor's vehicles must be off of the lot 1 hour prior to gates opening. **Any vendor who leaves before the show is closed on Sunday will not be invited back to another show. Vendors who drive onto the lot before all attendees are out of the gates will be banned from future shows.** Please understand that this is for the safety of our guests and vendors and your cooperation is extremely important! If we have to shut down the festival due to weather related issues, you may tear down. If the festival is not shut down, we ask that you do your best to cover and protect your products, but you may not tear down. You will not be asked back if you do. Storms blow over quickly in Las Cruces.

Deadlines & Refunds. No refunds will be given after July 20th and up until that date a \$25 fee is assessed for refunds.

Permits/Licenses. Gross receipts must be reported on your CRS form for Dona Ana County. All vendors must have a New Mexico CRS number on your application. All Vendors must have a Dona Ana County Business License. (To obtain one call 575-647-7350) Food Vendors and any vendors giving food samples must have a temporary health permit. For Health permits, contact the Dona Ana Health Dept. 2301 Entrada del Sol, Las Cruces, NM 88001, 575-288-2050. Vendors are responsible for all city and state permit fees.

Set up: Set up is on Thursday September 1st from 10:00 AM– 5:00 PM and on Friday September 2nd 8:00 AM – 4:00PM (times subject to change with notice) **Any vendor not checked in by 4:00 PM Friday Sept. 2nd will forfeit their space in the show.**

Other: Pets are NOT permitted.
